

# Are You Called to Serve at Hosanna?

The Hosanna Constitution states that President, Vice President/Mission Focus Team Leader, and the leaders of the other Support Teams (Staff Support, Lay Leadership, and Finance) shall be elected in even-numbered years. This election will occur at the June 8 Congregational Meeting and those elected will take office September 1.

The responsibility of preparing a slate of nominees belongs to the Lay Leadership Team. This team identifies willing individuals whose passions and gifts match the needs of the ministries, and issues a call to service to those individuals.

The Lay Leadership Team is requesting the help of the congregation in this process. On the next few Sundays, forms will be handed out that will give members of the congregation the confidential opportunity to suggest themselves or others for consideration as nominees for the positions listed below.

Provides overall leadership for the congregation's business and activities; presides at all meetings of the congregation and the Congregation Council; prepares the agendas for the meetings of the Congregation Council.
